

FULL GENERAL RELEASE AND LIABILITY WAIVER
Louisville Poker Society, Inc.

I, _____ (print name), desire to use or enter upon the land, property, facilities, and buildings (collectively, "Facilities") made use of by Louisville Poker Society, Inc., (hereinafter "Louisville Poker Society") in consideration of such use, I hereby make the following acknowledgments and agreements:

1. I understand that my visit to Louisville Poker Society may involve inherent risks of property damage and/or personal injury to me, to others under my supervision or control, or to others who accompany me. Such risks may arise from natural or manmade hazards, known and unknown, which may exist on the Facilities of Louisville Poker Society. Such risks may also arise from the presence of other persons of the Facilities made use of by Louisville Poker Society. By my signature, I acknowledge and assume all such risks and hazards and execute this release as to all such risks and hazards, **EVEN AS TO SUCH RISKS AND HAZARDS AS MAY BE THE RESULT OF THE NEGLIGENCE OF OWNERS OF THE FACILITY, LOUISVILLE POKER SOCIETY OR ITS OFFICERS, DIRECTORS, EMPLOYEES, MANAGERS, MEMBERS OR AGENTS. I AGREE TO BE SOLELY RESPONSIBLE FOR MY OWN SAFETY, THE SAFETY OF ANY PERSON UNDER MY SUPERVISION AND CONTROL, AND TO TAKE EVERY PRECAUTION TO PROVIDE FOR MY OWN SAFETY AND WELL-BEING WHILE ON OR USING THE FACILITIES MADE USE OF BY THE LOUISVILLE POKER SOCIETY.**
2. I understand that by signing this Waiver I assume all risks, known and unknown, associated with my use of the Facilities made use of by Louisville Poker Society. I release Facility Owners, Louisville Poker Society and its successors, assigns, officers, directors, employees, managers, members and agents from all liability arising from such use. This release of liability shall extend to all claims of any kind involving or relating to property damage, bodily injury, or death suffered or sustained by myself or any other person.
3. I hereby waive any right I might have to make claims or bring legal proceedings against Facility Owners, Louisville Poker Society or its successors, assigns, officers, directors, employees, managers, members or agents for any personal injury or property damage sustained by me, any person under my supervision and control, or any person who accompanies me onto the Facilities made use of by the Louisville Poker Society. This waiver expressly extends to all claims that may result from the negligence of facility owners, Louisville Poker Society or its officers, directors, employees, managers, members or agents to the fullest extent permitted by law.
4. I agree to indemnify, defend, and hold harmless Facility Owners, Louisville Poker Society and its successors, assigns, officers, directors, employees, managers, members and agents from any costs, liabilities, and attorneys' fees which may be incurred by it in any claim or legal proceeding I might bring in contravention of this Waiver or in any such claim or legal proceeding brought by a person who is under my control or supervision or who has accompanied me onto the Facilities of Louisville Poker Society. I further agree to indemnify and hold harmless Facility Owners, Louisville Poker Society and its successors, assigns, officers, directors, employees, managers, members and agents from any costs, losses, damages, and attorneys' fees (collectively, "Damages") suffered or incurred by Facility Owners, Louisville Poker Society or incurred by or to any persons or property located in or on the Facilities made use of by the Louisville Poker Society, and which Damages arise in any way out of my presence in or on the Facilities made use of by the Louisville Poker Society, or the presence of any persons under my control or supervision, or others who have accompanied me onto or into the Facilities made use of by the Louisville Poker Society which Damages arise from my acts or omissions or the acts or omissions of any such persons.
5. I agree that this release shall be governed for all purposes by Kentucky law, without regard to any conflict of law principles. This release supersedes any and all previous oral or written promises or other general release and liability waivers.
6. In the event that any damage to equipment or facilities occurs as the result of my or to others who accompany me willful actions, neglect or recklessness, I acknowledge and agree to be held liable for any an all cost associated with any such actions of neglect or recklessness.
7. If any provision of this Waiver is ruled to be invalid or illegal, such ruling shall have no effect upon the remaining provisions, which shall be considered legally binding and given full effect.

THIS WAIVER AND RELEASE OF LIABILITY SHALL REMAIN IN EFFECT FOR THE DURATION OF MY PARTICIPATION IN THE ACTIVTY, DURING THIS INITIAL AND ALL SUBSEQUENT EVENTS OF PARTICIPATION.
